We so appreciate the deep investments in time and resources that our many friends, supporters, and partners have made in Echoing Green's work over the past year. They have recognized the importance of our work by equipping us with the resources, through our new Racial Equity Philanthropic Fund, to leverage the potential of social innovation in the fight for racial equity.

The year 2022 marks the second year of programming fueled by the Fund. We look forward to learning alongside our community as we continue this work and drive more resources-and social impact-to social innovators of color. But 2022 also marks the 35th anniversary of Echoing Green's founding. 


Echoing Green drives change where social justice and social innovation meet, backing bold innovators leading the charge on transformational change across the globe.

Echoing Green is a lifelong community. We are making follow-on investments into alumni Fellows making strides toward racial justice.




This year, in addition to investing in early-stage innovators, Echoing Green has provided over \$1 million in follow-on funding grants to alumni

Fellows. Awarded after their active Fellowship term, this investment has supported 60 alumni to date whose social enterprises advance racial justice globally. Kara Bobroff, founder of the Native American Community Academy and a 2005 Echoing Green Fellow, is using her follow-on funding to scale her new

community-driven initiative at One Generation: The One Gen Fund. This grant will fuel efforts to identify promising, early-stage innovations that build sustainable solutions for Indigenous communities, deepen national efforts in Indigenous education, and support Indigenous leaders poised to change systems. With Indigenous culture, history, and stories at the forefront, Kara and the One Gen Fund are restoring cultural sovereignty to Indigenous communities across the United States.

This additional support once again leads the way, acting as a beacon for other allies to believe in our 'scale-as-depth,' culturally rooted approach to educational justice."

Dedicated to building a sustainable movement of local leaders to transform Haiti's education system, Nedgine Paul Deroly is using her follow-on



funding to drive Anseye Pou Ayiti's mission of recruiting and equipping 50,000 Haitian civic leaders by 2025. Rooted in the wisdom of Haitian culture, customs, and community, Anseye Pou Ayiti is breaking down systems of oppression in classrooms and communities by mobilizing proximate leaders to advance educational justice and liberation in the world's first Black republic.



With the support of Echoing Green's follow-on funding, 2019 Fellow and founder of FreeCap Financial Tanay Tatum-Edwards successfully

launched their first product: the first data set and accompanying report rating the S&P 100 based on its criminal justice footprint. By providing data on social justice-oriented issues such as fair hiring practices and use of prison labor, FreeCap equips investors, universities, and companies with the tools to leverage capital markets to dismantle the prison industrial complex and end mass incarceration.

As Mnandi Africa strengthens and sustains its storytelling efforts to raise funds and expand reach, Echoing Green's follow-on funding helps the organization to transform the lives of families and tribal communities across Zimbabwe.

EXPANDING OUR))) EGOSYSTEM

Collective action is required to drive systemic change and tackle a growing number of social and environmental challenges. In 2021, Echoing Green collaborated across sectors to strategically support Fellows, connect them with local leaders and organizations, create new and shared value, and move the needle forward on transformational social change. By forming new partnerships and building upon existing collaborations, the Echoing Green ecosystem supported hundreds of leaders and ideas at the intersection of social justice and social innovation.

Echoing Green's \$75M Racial Equity Philanthropic Fund

Echoing Green's three-year Philanthropic Fund (2021-2024) will ensure that 2020's heightened awareness of racial inequity translates into sustained action in the social innovation field. Echoing Green is raising funds to:

- Launch and scale 500 social enterprises whose work advances racial equity
- Improve social innovation on-ramps for 5,000 emerging leaders by partnering to develop and deliver programming and workshops to people at different leadership stages
- Engage 10,000 corporate employees with the tools to drive racial equity at their organizations and within their communities



When We All Thrive

In partnership with Comcast NBCUniversal, we hosted a discussion with racial justice and social innovation leaders on how driving more resources to the efforts intentionally confronting racial inequities—led by those closest to the challenges and solutions—can quicken the pace toward a more just world. We partnered with 11 companies to provide hands-on advice and mentorship to our Fellows.



Echoing Green's Social Innovation Challenge

Echoing Green presented the fourth annual Social Innovation Challenge, a series of leadership and pitch-coaching workshops for social innovators of color whose enterprises accelerate economic inclusion, narrative shifts, and systems change across the United States. The series culminated in a pitch event where 13 dynamic founders shared their visions for change in their communities, and each received grants of up to \$20,000 to further their impact. Season 2 of On Course

In partnership with Citi Foundation, Echoing Green launched the second season of *On Course*—a podcast that dives into the social entrepreneurship journey by digging into the backstories and motivations of its guests, who work in a range of fields, from STEM education to climate justice. Season 2 featured six Echoing Green Fellows who shed light on the challenges, optimism, and rewards of launching and driving movements rooted in social justice.

UPDATES FROM OUR COMMUNITY

Echoing Green has funded nearly 1,000 Fellows since its founding. The early-stage investments made in these leaders are often pivotal moments for their social enterprises, personal leadership journeys, and the world. Block by block, Donnel Baird '12 expands access to green energy jobs to save the planet

Donnel Baird '12, founder and CEO of BlocPower, raised more than \$60 million in 2021 from anchor investors like Goldman Sachs to advance BlocPower's mission to bring clean, affordable, and reliable energy to low-income neighborhoods in U.S. cities. The *Washington Post* detailed how Donnel and BlocPower are building community power and wealth at the intersection of economic, racial, and climate justice. Kathryn Finney '16 launches Genius Guild and raises \$5 million to support Black entrepreneurs

On the heels of the events of the summer of 2020, Kathryn Finney '16 launched Genius Guild, a business creation platform that uses the venture studio model to invest in Black entrepreneurs building scalable businesses that serve Black communities and beyond. In this past year, Kathryn has raised \$5 million as she continues her work to propel Black entrepreneurs and innovation forward.





Pharrell Williams's Black Ambition names Felecia Hatcher '17 as new CEO

In 2021, Felecia Hatcher '17 stepped down from her role at the Center for Black Innovation to lead Black Ambition, a nonprofit launched by Grammy-winning artist Pharrell Williams that funds projects and companies led by Black and Latinx entrepreneurs. Felecia brings her experience leveraging tech and innovation to build equitable economic pathways in support of Black Ambition's goal of funding the ideas of promising founders to ultimately build generational wealth among Black and Latinx communities.

Shivani Siroya '11 and Tala raise \$145 million to build upon world's most accessible financial platform

For the past 15 years, Shivani Siroya '11 has been laser-focused on building financial services accessible to underbanked people worldwide. She founded Tala, a fintech company that uses smartphone data to extend loans to people with little or no borrowing history who are otherwise locked out of the formal financial sector. This Series E funding round will support Tala's mission to increase financial access and inclusion in emerging markets and shift the world's financial infrastructures from serving the few to the many.

Echoing Green board member and 2011 Fellow Dr. Raj Panjabi brings a wealth of expertise in global health, social entrepreneurship, and experience reshaping inequitable health systems in rural communities to his new role as the U.S. Global Malaria Coordinator.

Welcoming a new class of Fellows – Meet the 2021 Class

In 2021, Echoing Green welcomed 18 new leaders to our global community of change-making innovators. The 2021 Echoing Green Fellows are tackling societal challenges like lack of health care for displaced communities in the Middle East, systemic and generational trauma for Detroit youth, and energy inequities faced by ethnic communities in rural Myanmar. They are operating in nine countries and territories (Kenya, Libya, Malawi, Mexico, Myanmar, Oman, Puerto Rico, Somalia, and the United States) and multiple U.S. cities including Detroit, Nashville, Oakland, San Antonio, and Washington, D.C. With seed funding, collaborative communities, and holistic support, these Fellows are ready to reimagine inequitable systems alongside their communities and with their cohort.

The year 2021 was transformational for Echoing Green and our closest supporters. We launched new partnerships with institutions to accelerate the impact of emerging and established social impact leaders this year that will take root and blossom in 2022. We are excited for continued growth-from expanding social innovation workshops with students at Spelman College to new partnerships to support and invest in proximate leaders working on a range of issues like immigrant rights and supporting Black women and girls. We are committed to the ongoing journey to build a just, sustainable world.

With the COVID-19 pandemic still ongoing and global inequality on the rise, major sectoral shifts are vital to this effort to advance racial equity. Our work to improve access to capital and amplify the voices and narratives of people committed to disrupting inequity and building opportunity will remain central to Echoing Green's activities in the months ahead. The past 35 years of our impact have been fueled by the courage, wisdom, and optimism of the leaders we support. We hold steady in our belief in this community's potential to make waves and drive big, bold change long into the future.







